Important Dates and information

- 1. The Jog 100km in October Challenge will run between Thursday 1 September 2022 and Friday 4 November 2022.
- 2. Proceeds of this fundraising activity are in aid of Australian Red Cross Society ABN 50 169 561 394 ("Red Cross") after deduction of fundraising expenses (administration costs).
- 3. Consistent with Facebook account policy, the Jog 100km in October Challenge and entry into the prize draw is open to participants aged 13 years and over. Participants under 18 years must obtain permission from a parent or other legal guardian to participate.

Prizes and Notification

- 1. The total prize pool is \$299.99 AUD. The prize to be won consists of one (1) Lego Technic McLaren Formula 1[™] Race Car signed by Daniel Riccardo and Lando Norris.
- 2. All participants who raise over \$200 via their fundraising page (through their Facebook fundraiser or Act for Humanity platform) by 9:59am AEST on Friday 4 November 2022 will go into the draw to win the McLaren Formula 1 Race Care Lego set signed by Daniel Riccardo and Lando Norris.

- 4. The winner will be notified within three (3) business days of the draw by the Jog 100km in October Challenge Campaign Coordinator, and the name of the winner will be published on the Jog 100km in October Challenge Facebook group page.
- 5. If the winner's phone number and email are known, the Jog 100km in October Challenge Coordinator will attempt to call the winner three (3) times followed by an email to notify and confirm delivery details/address for the prize.
- 6. If the winner's phone number and email are not known, the Jog 100km in October Challenge Coordinator will attempt to contact the winner via Facebook Messenger to notify and confirm delivery details/address for the prize.
